### 2. Hazards Identification

## 4. First Aid Measures

### First aid procedures

<b>Eye contact</b>	Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention immediately.
<b>Skin contact</b>	Remove and isolate contaminated clothing and shoes. Immediately flush skin with plenty of water. Get medical attention immediately. For minor skin contact, avoid spreading material on unaffected skin. Wash clothing separately before reuse.
<b>Inhalation</b>	Move to fresh air. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a physician or poison control center immediately.

## 5. Fire Fighting Measures

### Flammable properties

### Extinguishing media

## 6. Accidental Release Measures

**Personal precautions** Keep unnecessary personnel away. Fully encapsulating, vapor protective clothing should be worn for spills and leaks with no fire. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Keep people away from and upwind of spill/leak. Keep upwind. Keep out of low areas. Ventilate closed spaces before entering them.

**Environmental precautions** Prevent further leakage or spillage if safe to do so. Do not contaminate water.

**Methods for containment** ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. This material is classified as a water pollutant under the Clean Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways.

**Methods for cleaning up** Should not be released into the environment.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills in original containers for re-use. Following product recovery, flush area with water. For waste disposal, see section 13 of the MSDS.

## 7. Handling and Storage

<b>Handling</b>	DO NOT handle, store or open near an open flame, sources of heat or sources of ignition. Protect material from direct sunlight. Do not get this material in contact with eyes. Do not get this material in contact with skin. Avoid breathing dust/fume/gas/mist/vapors/spray. Do not get this material on clothing. Wear personal protective equipment. Do not use in areas without adequate ventilation. Wash thoroughly after handling. Avoid release to the environment.
<b>Storage</b>	Keep away from heat, sparks and open flame. Store in a well-ventilated place. Keep container tightly closed. Do not store near combustible materials. Keep out of the reach of children. Use care in handling/storage. Store in tightly closed original container in a dry, cool and well-ventilated place. Keep from contact with oxidizing materials, highly oxygenated or halogenated solvents, organic compounds containing reducible functional groups, or aqueous ammonia.
